**Waste Regulations**

**Trash Collection Day is every Tuesday. Please have your materials prepared & at the curb by 7:00AM.**

- 1 - Residents are limited to six (6) bags per week with a maximum 50 lbs weight limit per bag and 35 gallon size limit. Additional bags of trash can be picked up at a resident cost of \$1.00 per bag. Please contact Stevens Disposal to make arrangements and make payment.
- 2 - **ALL TRASH MUST BE PLACED IN BAGS ONLY.** No containers, trash cans, boxes, baled paper, baled cardboard, etc. will be emptied or removed by the contractor. Refuse shall be set out for pick-up on the city right-of-way on city streets only. No refuse shall be set out for pick-up prior to 6:00 p.m. the evening before the scheduled day of pick-up.
- 3 - No person shall give permission to another individual to place refuse or other waste material in the public right-of-way for collection when such waste material was not generated by the private premises immediately adjacent to such private right-of-way.
- 4 - By City Ordinance, trash service will be provided to "residential" properties defined in the Ordinance as "dwellings occupied by single-family units, duplexes, condominiums, apartments of four units or less, and shall not include motels, hotels, limited care facilities, hospitals, transitional homes, adult foster care homes, nursing homes, halfway houses, licensed mobile or manufactured home parks, campgrounds, or any other property used for commercial purposes."
- 5 - Large, bulky items, such as furniture and appliances are collected the same day as regular trash (Tuesdays). The cost is \$5.00 per item and must be paid for in advance. You must contact Stevens Disposal @ 800-779-0344. They accept Visa, Master Card, American Express, and check by phone at no additional charge.
- 6 - Appliances: Resident's are responsible for the removal of Freon Refrigerants from applicable appliances (freezers, refrigerators, air conditioners) prior to collection. A certification label must be affixed to the appliance. This requirement is mandated by Federal Law.
- 7 - Exclusions: Curbside collection excludes the following materials: Yard waste, including brush, grass, leaves, & shrubs; auto parts & tires; building materials, including paint, concrete, metal pipes, and rocks; liquids, motor oils, hazardous chemicals, pesticides, insecticides; dead animals. If you have questions regarding the handling or acceptability of an item, please contact Stevens Disposal or the City Offices. **NO HAZARDOUS WASTE.**
- 8 - Holiday Collection Schedule. Stevens Disposal & Recycling Service observes the following six (6) holidays; January 1 (New Years Day), Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, and Christmas Day. There will be no collection on these holidays. If the holiday falls on a Monday or Tuesday, your pick day will be delayed by one day and will be done on Wednesday.
- 9 - Beginning July 1, 2014 residents will begin paying for trash service at a cost of \$30.00 per quarter. The first bill will be sent in late May and will be due on July 1, 2014. There is no "opt-out" for this service or fee for any reason. If a property is deemed uninhabitable after inspection by the City Code Enforcement Officer, this fee may be waived. Multi-unit dwellings will be billed according to the number of units on the property, (i.e.; a 4-unit building will be billed for 4 units of trash service.

**RECYCLING GUIDELINES**

Curbside recycling is available through Stevens Disposal & Recycling Service by subscription only and the resident must contact the City of Adrian to sign up for this service. The cost for the recycling service must be pre-paid to the City of Adrian. Starting July 1, 2014 the cost will be \$31.80 for the next year. Bills and inquiries will be forthcoming.

It is an every other week service with a Stevens supplied 96 gallon cart on wheels. **Same as with the waste regulations, please have your materials prepared and wheeled to the curb by 7:00AM.**

**PLEASE MARK YOUR CALENDAR WITH THE FOLLOWING RECYCLING SCHEDULE:**

Recycling is done every other week on Tuesdays. Stevens will service the NORTH side of Maumee Street and all other streets NORTH beginning with Tuesday, January 14, 2014 and will be every other Tuesday thereafter. Stevens will service the SOUTH side of Maumee Street and all other streets SOUTH beginning with Tuesday, January 7, 2014 and will be every other Tuesday thereafter.

It is co-mingled recycling, you do not need to sort your recyclable items, all recyclables go in the Stevens supplied 96 gallon cart. Items are not required to be bagged, however, if you choose to bag your recyclables, they must be put in **CLEAR BAGS ONLY**.

Acceptable recycle items include:

Newspaper, magazines, cereal box & soft drink box type paperboard.  
Clear, green, and brown glass bottles and jars. Please remove lids and rings. Rinse clean.  
Plastics #1 through #7; Remove lids and rings. Rinse clean. Flatten to save space.  
Aluminum and steel cans: rinse and clean. For safety, please place lid inside can and pinch the end closed.  
Brown or White Corrugated Cardboard: Remove all packing materials. Break down boxes to conserve space. You may leave tape, staples, and labels.

**Non-Acceptable items for recycling include:**

Window glass, styrofoam items such as packaging materials & cups, paper milk & juice cartons, any waxed cardboard, propane tanks, wood, & paint cans. Please call if you are unsure of items you wish to recycle.
